Key Findings/Summary

Familiarity with the wild horse issue

• <u>Three fourths of the respondents (74.9%)</u> said they were familiar or very familiar with the Placitas wild horse issue. Respondents were aware of the issues and qualified to respond to the questions.

Responses to Wild Horses remaining as free managed horses in Placitas

• **85.7%** of the respondents want the Placitas horses to remain as managed free roaming horses in Placitas on public and/or private lands, with yearly birth control as needed and cattle guards with fencing as needed for road safety rather than having them rounded up and moved out of the area (14.3%).

(the margin of error was +/-3.4%-82.2%-89.2%)

Where they should be managed respondents that want them managed in Placitas responses)

- 44.1% of the respondents who want the horses to remain in Placitas prefer the horses to be managed in a designated Wild Horse Sanctuary utilizing the 3,000 acre Bureau of Land Management (BLM) public lands called the "Buffalo strip", on the north side of Placitas
- <u>25.2%</u> of the respondents prefer having the horses managed on all unfenced private lands AND all public lands in and adjacent to Placitas
- <u>18.2%</u> of the respondents prefer having the horses managed on a designated Wild Horse Sanctuary utilizing the Albuquerque Open Space public lands in Placitas AND the BLM Lands called the "Buffalo strip".
- **11.9%** of the respondents had no opinion.

Support of building the Northwest Corridor

- <u>87.3%</u> of the respondents <u>do not</u> support the building of the northeast corridor connecting I-25 to I-40 through Placitas, BLM land, Hwy 165 and Hwy N14 in order to facilitate gravel mining and development in Placitas and likely not allow for the free roaming horses?
- <u>5.2%</u> of the respondents refused to answer the question and many answered with the caveat that the question was off topic and biased as it had only two options.

(the margin of error was +- 3.2%-90.5%-84.1%)

Demographics

- All respondents were residents of Placitas.
- Residency for respondents varied from new residents (1 year or less) to respondents that had lived in the village for 60 years. The average length of residency for respondents was 16 years.
- The average age of respondents was 63 years old. The average of respondents ranged from 26-91 years old.

Overview

The Wild Horse Observers Association (WHOA) contracted with Southwest Planning (SWP) to conduct a third-party unbiased poll of representative Placitas Citizens in order to determine the majority opinion of these citizens with regard to the Wild Horse issue on Placitas.

Research Goals

Determine the percentage of people that want the horses in Placitas to run free and if so, in what physical environment.

Research Methodology

- SWP met with WHOA officials to determine the goals of the phone poll.
- SWP prepared a short phone survey consisting of seven quantitative (closedended) questions (see Appendix A for survey instrument. The questions were designed to garner the opinion of Placitas residents.
- SWP utilizing computer aided phone dialers called a random list of 900 Placitas Households (approximately 1/3rd of all Placitas households).
- Surveys were conducted on:


Tuesday August 19,from 5:00pm - 9:00pm. Wednesday August 20, from 5:00pm - 9:00pm. Sunday August 25th ,from 4:00pm - 9:00pm. Monday August 26th 2014 from 4:00pm - 8:00pm.

- In order to get an unbiased sample each of the randomly dialed 900 phone numbers, a minimum of five attempts were made to contact the household over the four survey days. Twenty percent (20%) or 208 households) of the respondents completed a survey.
- SWP surveyors were provided an hour of training regarding the issue and calls were randomly monitored and recorded.
- SWP staff prepared a statistical analysis and report.

Frequencies/Statistics

Total number of responses collected: 208

Q1. On a scale from 1-10, with 1 being very unfamiliar and 10 being very familiar, how familiar are you with the local wild horse issue in Placitas?



Three fourths of the respondents (74.9%) said they were familiar or very familiar with the Placitas wild horse issue.

18.2% of the respondents prefer having the horses managed on a designated Wild Horse Sanctuary utilizing the Albuquerque Open Space public lands in Placitas AND the BLM Lands called the "Buffalo strip".

11.9% of the respondents had no opinion.
