## **QUESTIONS INCLUDE;**

- 1. Is Udall going to allow the Land Grant take the fall for the Developers and special interests for the Loop RD the people strongly oppose?**
2. Does Udall admit that the Placitas Horses are legally wild as per his letters to Placitans?
3. Why does the Placitas issue require a Washington staffer/staff to figure it out?
4. It is not a local issue and if not, what makes it a Washington issue?
5. This BLM is less than 5000 acres.
6. How much influence does Mary-Rose de Valladares have over Udall's Washington staff?
7. What is Mary-Rose de Valladares plan for the BLM?
8. Why does Mary-Rose de Valladares work with the BLM Udall's office and Congress to get the RMP funded and then put no comments into the Scoping Report?
9. Is it OK for Sandoval County to be submitting their requests for a Loop Rd to the BLM marked confidential under the Privacy Act?
10. Will realtors now be liable for selling property in Placitas and not informing their clients of the possibility or imminent Loop Rd?
11. Is Udall going to ask the House or the Senate for a Moratorium on Land Tenure Adjustments? Does Udall understand that the Land Grant was not aware of this request?
12. Are the Land Grants taking the blame for the Loop Rd vs. the many special interests/ out of state developers?
13. Is Udall going to protect and preserve the Wild Life Corridor from Canada to Mexico supported by the Western Governors which is broken only here at Sandia?
14. Is Udall going to protect and preserve New Mexico's wild horses which exist in Placitas?
15. Is Udall going to represent the people and tell the BLM and Sandoval County no Loop Rd on the BLM or will the special interests who want this Loop Rd be supported by action and even inaction?

## REQUESTS

Hear the people: Represent the people in support of the Wild Life Corridor /Wild Horses against the Loop Rd.  
Close the Right of Way ( North Mustang HWY) onto the BLM immediately.  
Tell the BLM and Sandoval County government the people have a right to know all the options for the BLM and Placitas as well as what their government and their politicians are doing. End the County and the BLM's use of the Privacy Act to hide their actions and agendas.  
Permanently end this Loop Rd, the feigned Moratorium on the Loop Rd is only temporary and the Loop Rd is moving forward behind the scenes.

The people have a right to free speech and to be heard, and should have representation rather than the special interests.
