### What needs to happen for the Wild Horse State Park to become a reality?

1. State of NM does a *fiscal analysis*.

- o A fiscal analysis has been mandated by the NM Senate and the NM State Parks Dept. has agreed to do it before the end of this summer.
- 2. State of NM utilizes the *Federal Public Parks and Purposes Act* to acquire the BLM (which would be without cost to the State of NM).
  - There are a lot of details that lay beneath this and WHOA is gathering and organizing the resources to make this happen. Alternatively, WHOA has also developed back-up plans.

### Competing proposals for the Placitas-area BLM:

### **NE Corridor Highway (Loop Rd)**

- Placitas does not need an additional access road (contrary to the County's rationalizations) and assertions), as it already has alternate emergency routes. Also, as a Big I bypass, it increases the likelihood of hazardous materials being routed through our area.
  - As per the Placitas Fire Chief, "From the perspective of an evacuation for a major catastrophic event scenario, we have not identified the need for another ingress or egress from the Placitas community"..."widen Hwy 165 to 4 lanes when needed."
  - Existing Ingress/Egress routes: Hwy165 to I-25, Hwy165 to the East Mtn, and Manzano Rd to I-25 Frontage Rd.
- o As it is currently conceptualized by Sandoval County, the road would increase the traffic congestion in the area and would bring truck traffic through Placitas. It would also require Eminent Domain takings of private property in Placitas.
- Residents of Placitas and the East Mountain are both opposed to the NE Corridor.
- **Energy Corridor** 
  - As currently conceptualized by Federal agencies, the implementation of the Energy Corridor would result in Eminent Domain takings of private property in Placitas.
